

COVID-19: RETURN TO WORK – EMPLOYEE ENGAGEMENT SURVEYS

Employee engagement and risk perception is key to adopting and maintaining new control measures and practices. Commitment and engagement are building blocks to create a strong COVID-19 prevention culture in an organization. An employee survey is an excellent way to assess workforce engagement, perception and understanding. The results can be used to build upon or to correct existing programs and communication strategies.

Two Surveys:

- 1. Pre-return survey Conducted prior to return to work to assess risk perception
- 2. Post-return survey Conducted 2-3 weeks after return to work and repeated as often as necessary

What to do with the results:

- 1. Look for trends with respect to employee understanding of risk or other issues
- 2. Develop additional communication or engagement to address trends and risks
- **3.** For post-return survey, re-administer survey 1-2 weeks after taking corrective actions
